Welcome to Meridian Chamber of Commerce’s 1st Annual Market on the Square.
Market Days are held on the fourth Saturday of the month, March through October.

1. Booth spaces are approximately 10’x15’ and are \$15.00 per space or \$10.00 if you are a Meridian Chamber Member
2. Booth Registration Form with signature at the bottom of the page must accompany your check or money order.
3. This is a RAIN or SHINE event. No refunds will be made for inclement weather.
4. Any check returned for insufficient funds will be charged an additional \$30.00 fee.
5. Booth space will be on a first come, first served basis.
6. Large trailers and/or vendors with generators will be assigned to particular areas and will be charged for additional space.
There is no electricity or water available. All generators must be “quiet”.
7. Set up starts at 7:30am and should be completed by 9:00am.
8. Vendors must park their vehicles in public parking areas: no parking in front of businesses on the square.
These spaces are reserved for the customers of the businesses and Market on the Square customers.
9. We have the right to refuse any items for sale we feel are unacceptable or not in the best interest of “Market on the Square”. Items NOT allowed: Weapons, Satanic items, or any other items prohibited by law.
10. We have the right to ask any vendors to leave who are not complying with the rules or conducting themselves in a professional manner. Remember this is a family event.
11. Vendors are responsible for the merchandise, security and liability of their booths and persons. Vendors shall indemnify and hold The Meridian Chamber of Commerce and/or the City of Meridian harmless from any and all loss.
12. The Meridian Chamber of Commerce promotes our “Market on the Square” in newspapers and other venues throughout the surrounding areas. Please let us know if you have a suggested publication.
13. **All garbage, boxes and bags must be picked up and taken with you. No garbage, boxes or bags are to be left behind.**
